HOW AND WHEN TO ENROLL

Total registration for the Traffic Program **MUST BE COMPLETED WITHIN TEN (10) WORKING days*** after the receipt of the citation or you will be ineligible and need to pay the citation.

**Total registration includes having the completed paperwork to Traffic Safety Plus within the 10 working days.*

3. COMPLETION OF CLASS

You must complete the program within 60 days after receipt of the citation. Charges will be filed in court pending completion of the program and dismissed upon satisfactory proof of completion.

YOU ARE ELIGIBLE

If your citation was for:

- Speeding (not more than 19 m.p.h over speed limit)
- Disregarding traffic signs and signals
- Failure to yield the right-of-way
- Wrong way, wrong side or improper passing
- Following too closely
- Driving too fast for conditions
- Driving left of center/Crossing the center line
- Improper turns, backing or lane changes
- Misuse of school permit
- Careless driving
- Overloading front seat

***If you have NOT
Participated in a
S.T.O.P program in
the last 3 years**

YOU ARE NOT ELIGIBLE

If your citation was for:

- Any injury accident
- Refusing a breath or blood test
- CDL Operator's License Holder
- Participating in a speed contest
- Major traffic citations (leaving the scene of an accident, driving under the influence of alcohol and/or drugs, willful reckless or reckless driving)
- Operating a vehicle without insurance or other financial responsibility.
- Speeding twenty (20) or more miles per hour over the speed limit
- Driving on a suspended or revoked operators license
- Any misdemeanor or felony
- Operating a motor vehicle to avoid arrest
- Construction zone citations
- Exhibition of acceleration
- Citations for multiple violations, except for:
 - Proof of insurance not in vehicle
 - Not wearing a seatbelt
 - Valid driver's license not on person
 - Valid registration not in vehicle

*The County Attorney has the
right to refuse or accept any
individual.*
