Instructions to Complete Handgun Purchase Permit

Handgun Purchase Permit Requirements

- Must be 21 years or older to apply for permit.
- Must be a Loup County Resident.
- Nebraska ID with current address listed.
- Answer the non-immigrant alien question (if you are a US citizen check non-applicable)
- Each box/question must be answered.
- Incomplete applications will be denied.
- Complete included Contact Form listing all additional names used, including maiden names, and preferred phone number for contact.

If you meet the above requirements, you will then need to make application for a certificate to:

- Purchase
- Rent
- Lease
- Receive Transfer of a Handgun

There is a \$5.00 fee due when the application is made, and a criminal history check will be performed. If the certificate is issued, it is valid statewide for three years. With a certificate in hand, you then can go to the dealer of your choice and select the weapon you wish to purchase.

Applications will be made between the hours of 8:30am-4:00pm Tuesday and Friday, by appointment or by mail. Applications will NOT be accepted on Saturdays, Sundays, or Holidays.

Applications can also be printed offline from the Loup County Courthouse website under the Sheriff's Section. Printed applications can either be mailed in using the instructions below or brought to the Sheriff's Office filled out. If you fill it out ahead of time you cannot sign the application until you are in front of an employee from the Loup County Sheriff's Office.
