The Loup County Board of Commissioners met pursuant to adjournment this 11th day of September, 2024 at 8:30 a.m. at the Loup County Courthouse in Taylor, Nebraska. Present were Commissioners Larson, Steckel, and Ruppel, County Clerk Copsey, Deputy Clerk Moon. County Attorney White and County Engineer Johnson were present later in the morning. Chairman Larson called the meeting to order. Board members acknowledged receipt of the August 14th, 2024 meeting minutes. Steckel moved to approve the minutes with no additions or corrections. 2nd by Larson. Roll call vote; yes; Steckel, Larson, Ruppel. Nays; none absent; none not voting; none. Receipt of advance notice and agenda for the September 11th, 2024 meeting was also affirmed by all members present. Chairman Larson referenced the Open Meeting Laws poster located in the meeting room and advised that handouts concerning said laws are available to the public.

Steckel moved for the adoption of a resolution transferring monies from the General Fund to the Road Fund. 2nd by Ruppel. Roll call vote; yes; Steckel, Ruppel, Larson. Nays; none absent; none not voting; none. Said resolution can be found in Commissioners Record No. 10 Page 482.

The Board reviewed the Clerk of the District Court monthly fee report, fund balances from Treasurer, and the Treasurer's tax remaining report.

Ed Knott, from Applied Connective met with the Board to provide information regarding IT services that his company provides. He presented a proposal for the Board to review. Summer Strohl met with the Board to discuss the current courthouse chairs and the estimated cost of re-covering them versus the purchase of new chairs. Steckel approved Summer to go ahead with re-covering the current courthouse chairs.

Tim Jordan, Village Chairman and Nicole O'Conner, Village Clerk met with the Board to present the contract for leasing the land from the county to build the new Village building on. Attorney White discussed that the contract needs to include a provision for either party to get out of the lease if necessary. Steckel moved to enter into a lease agreement with the Village of Taylor for use of Lots 1, 2, and 3, in Block 10 for an initial non-terminable period of 50 years by giving the other party a 2-year written notice. 2nd by Ruppel. Roll call vote; yes; Steckel, Ruppel, Larson. Nays; none absent; none not voting; none.

County Engineer Johnson discussed the easement agreement with BTAZ, LLC including cost of \$100 for temporary easement and \$1,000 for permanent easement and that the county will be responsible for removing and replacing the fence.

Steckel moved to approve temporary and permanent easements with BTAZ, LLC. 2nd by Larson. Roll call vote; yes; Steckel, Ruppel, Larson. Nays; none absent; none not voting; none.

The Board discussed insurance stipend for part-time employees. No decisions were made.

Steckel moved to approve the contract with Dixon Construction for the Loup County CBMP, C-58 bridge project. 2nd by Ruppel. Roll call vote; yes; Steckel, Ruppel, Larson. Nays; none absent; none not voting; none.

Bob Osborne, Land Agent from American Legacy Land Company met with the Board to discuss the issue of establishing a boundary for the 200 acres owned by Bootleg Brewers, due to lack of information for the section. County Engineer Johnson gave his opinion that the county has no financial responsibility to find the corner. County Engineer Johnson will speak with the surveyor involved in regards to moving forward. No decisions were made. Cody Griffith, from EZ IT met with the Board to discuss the IT services his company currently provides and explain changes with billing.

Discussion during public comment section included but not limited to: Jackie Lurz- county budget, Tootie Ruppel- equipment purchases, Sam Fales- claims process.

There being no further business, the Board adjourned at 11:00 a.m.
