The Loup County Board of Commissioners met pursuant to adjournment this 8<sup>th</sup> day of October 2025 at 8:30 a.m. at the Loup County Courthouse in Taylor, Nebraska. Present were Commissioners Larson, Steckel, and Kraus, County Clerk Copsey. County Engineer Johnson was present later in the morning. Chairman Larson called the meeting to order. The Board reviewed the Clerk of the District Court monthly fee report, fund balances from Treasurer, the Treasurer's tax remaining reports, the Treasurer's distress warrant report, and the Sheriff's Quarterly Report.

Larson moved for the adoption of a resolution transferring funds from the General Fund to the Ambulance Fund in the amount of \$9,126.92. 2<sup>nd</sup> by Steckel. Kraus moved for the adoption of a resolution transferring funds from the General Fund to the Road Fund in the amount of \$45,718.87. 2<sup>nd</sup> by Steckel. Board recessed for Board of Equalization meeting at 9:30 and returned to regular session at 9:32 a.m.

Road Foreman, Dustin Copsey provided road department update including but not limited to putting in new culverts and auto gates, equipment breakdowns, and personnel.

County Clerk Copsey discussed with the Board current expenditures for the new road department building. Discussion included estimated expected costs remaining to complete the building. Caleb Johnson, the county's budget preparer, met with Board via phone to discuss building expenditures and options for repaying money to the inheritance fund.

County Engineer Johnson discussed with the Board that the CBMP program may expire after this year, so he encouraged everyone to reach out to their Senators in support of keeping this program. He reports the 823<sup>rd</sup> project looks good and also provided an update on the South Lake Road guard rail.
