The Loup County Board of Commissioners met pursuant to adjournment this 14th day of January 2026 at 8:30 a.m. at the Loup County Courthouse in Taylor, Nebraska. Present were Commissioners Larson, Steckel, and Kraus and County Clerk Copsey. County Engineer Johnson was present later in the morning. Chairman Larson called the meeting to order. Board members acknowledged receipt of December 10th, 2025, meeting minutes. Steckel moved to approve the minutes with no additions or corrections. 2nd by Kraus. Roll call vote; yes; Steckel, Kraus, Larson. Nays: none, absent: none, not voting: none. Receipt of advance notice and agenda for January 14th, 2026, meeting was also affirmed by all members present. Chairman Larson referenced the Open Meeting Laws poster located in the meeting room and advised that handouts concerning said laws are available to the public. Also, present was Dustin Copsey. The Board reviewed the Clerk of the District Court monthly fee report, fund balances from Treasurer, the Treasurer's tax remaining reports, and Sheriff's Quarterly Report. County Treasurer Starr discussed the Treasurer's semi-annual statement and funds used to pay out claims.

The Board discussed stipend for Sheriff Office Manager, Ashley Spanel. Kraus moved to approve insurance stipend for Sheriff Office Manager Ashley Spanel at \$500 per month effective February 1st, 2026. 2nd by Larson. Roll call vote; yes; Kraus, Larson, Steckel. Nays: none, absent: none, not voting: none.

Board recessed for Board of Equalization meeting at 9:01 a.m. and returned to regular session at 9:04 a.m.

Larson moved to schedule the November 2026 commissioner meeting on Thursday, November 12th, 2026, due to Election Day on November 10th and Veteran's Day on November 11th. 2nd by Steckel. Roll call vote; yes; Larson, Steckel, Kraus. Nays: none, absent: none, not voting: none.

Kraus moved to adopt resolution to appoint Larson as representative for the Loup Central Landfill Association and continue interlocal agreement. 2nd by Steckel. Roll call vote; yes; Kraus, Steckel, Larson. Nays: none, absent: none, not voting: none. Said resolution can be found in Commissioners Record No. 10 Page 667.

Zane Young, County Weed Superintendent, was present to discuss the Weed Department Annual Report. Discussion included the number of complaints of noxious weeds and any need of forced spraying. Other topics discussed included the county's share and use of the equipment that was received through a grant submitted by the SWMA, spraying the ditches specifically in the areas where trees and brush have been removed to prevent/maintain regrowth. Road Department foreman, Dustin Copsey and Zane Young, Weed Superintendent will continue to remain in good communication to ensure spraying is being completed as necessary. Kraus moved to approve the Annual Report for the Weed Department. 2nd by Steckel. Roll call vote; yes; Kraus, Steckel, Larson. Nays: none, absent: none, not voting: none.

County Engineer Johnson provided an update on his ongoing discussion with Nebraska Department of Transportation regarding guardrail on South Lake Road. County Engineer Johnson will continue his discussion with NE DOT regarding responsibility for repair and/or replacement. Dustin Copsey, Road Department Foreman provided road department update including tree work and road maintenance.

Chairman Larson opened the One- and Six-Year Road Hearing at 10:30 a.m. Present were Commissioners Larson, Steckel, and Kraus, County Clerk Copsey, County Engineer Johnson, Road Department Foreman Dustin Copsey. County Engineer presented the One- and Six-Year Plan to the Board. Steckel moved to adopt a resolution to accept and approve the One- and Six-Year Road plan as presented. 2nd by Kraus. Roll call vote; yes; Steckel, Kraus, Larson. Nays: none, absent: none, not voting: none. Said resolution can be found in Commissioners Record No. 10 Page 668. Chairman Larson closed the One- and Six-Year Road Hearing at 10:45 a.m.

There being no further business, the Board adjourned at 10:46 a.m.
